## OSHA Form 300A Posting

February 1<sup>st</sup> through April 30<sup>th</sup>, employers with 11 or more workers are required to post their current OSHA Form 300A in the common area where notices to employees are usually posted and make a copy available to employees who move from one worksite to another.
